- 9.12 WHEREAS, the Board of Education has had an opportunity to review the 2016 Capital Project (hereinafter the "Project") proposed for the Hartford Central School District's Bus Garage, the Floyd Harwood Elementary School and the Hartford Middle/High School. This Project includes the following:
  - (1) The construction, reconstruction, alteration, and an addition to the Bus Garage with related site work;
  - (2) The interior and exterior renovations and repairs to the Floyd Hardwood Elementary School with related site work; and

WHEREAS, the Board of Education has had an opportunity to review the Project with regard to its classification under the State Environmental Quality Review Act (hereinafter referred to as "SEQRA") and whether it will have any significant adverse environmental impacts;

NOW THEREFORE BE IT RESOLVED THAT, pursuant to 6 NYCRR Part 617.5©(2) and (8), the Board of Education hereby declares that the Project be classified as a Type II Action under SEQRA because it is a replacement, rehabilitation or reconstruction of a structure of facility, in of gross floor area, and it's therefore exempt from SEQRA.

reconstruction, improvements, and alterations to the School District's Elementary School, the Middle/High School, and the Bus Garage, and to engage in the construction of additions to the School District's Bus Garage and to engage in site work on school District property, and to acquire original furnishings, equipment or apparatus required for the purpose for which the School District buildings are intended to be used in said School District (the "Project") at a cost not to exceed \$3,960,000, and that \$3,960,000 or so much thereof as may be necessary, shall be raised by the levy of a tax upon the taxable property of said School District and collected in annual installments as provided by Section 416 of the Education Law, and, in anticipation of such tax, obligations of said School District shall be issued.
