# TRANSFER TO CAPITAL PROJECT

<u>What?</u>

- Budget Line Item directing additional funds to a voter approved Capital Project
- No impact on the levy and the additional funds are eligible for Building Aid

<u>Rationale</u>

- Safeguard for escalation of costs and inflation
- Insurance to ensure the discussed scope of work can be completed (*non-guarantee*)

Source of Funds

• Fund Balance through SSBA Reimbursement (*Access Control Project*)

- 1 66 Passenger Bus
- Not to exceed a cost of \$160,000

#### **SAMPLE BALLOT**

#### 2023-2024 DISTRICT BUDGET

RESOLVED, that the Board of Education of the Hartford Central School District be and is hereby authorized to expend for school purposes during the fiscal year commencing July 1, 2023, General Fund appropriations of \$14,315,400 and to levy the necessary tax therefore.



#### VEHICLE PURCHASE PROPOSITION

RESOLVED, that the Board of Education of the Hartford Central School District is hereby authorized to purchase one (1) 66 passenger bus at a total cost not to exceed \$160,000 and that the sum of \$160,000 or so much thereof as may be necessary shall be raised by the levy of a tax upon the taxable property of said School District and collected in annual installments as provided by the Education Law and the Local Finance Law, and in anticipation of such tax, obligations of said School District shall be issued.



#### **BOARD OF EDUCATION MEMBER**

The Hartford Central School District Board of Education is comprised of five members. There is one expired term, with one Board member to be elected for a term commencing July 1, 2023.
