RESOLVED, that the Board of Education hereby determines that, pursuant to Section 75 of the New York State Civil Service Law, there is probable cause to proceed with the three charges reviewed by the Board of Education in today's Executive Session against the civil service employee discussed in today's Executive Session; and it is further

RESOLVED, that the Board of Education hereby appoints Patrick Dee as the Hearing Officer to conduct a hearing on said charges pursuant to Section 75 of the New York State Civil Service Law; and it is further

RESOLVED, that the Board of Education hereby suspends without pay the civil service employee discussed in today's Executive Session, commencing April 5, 2023 pending the hearing and determination of said charges pursuant to Section 75 of the New York State Civil Service Law.
